#### **ORGANISATION FEES**

Organisation fees are due by the organization (*you*) for the inscription of the event to the IFSA calendar.

#### AMOUNT

The amount of the organisation fees is fixed and revised every year during the annual IFSA board meeting.

#### TERM OF PAYMENT

#### CANCELLATION POLICY

Cancellation up to a hundred and twenty days (120) prior to the event: inscription fees are refund in the total.

Cancellation inferior of the one hundred and twenty days delay prior to the event: the inscription fees are kept entirely.



### JUDGE FEES

Judge fees concern all the expenses that the organization have to take care about, regarding the four IFSA Official Judges.

## **OBLIGATIONS**

Judge fees concern:

- Judges' travels.
- Judges' Accommodations and meals.
- Judges' payments.

### JUDGES TRAVELS

Prior to the event, the organisation have to take care about the travel of the judges from their place in their country to the place of the event.

Judges' travels are paid directly to judges with the help of the judge manager. Travels have to be arrange and paid by the organisation and tickets have to be transfered to the judges prior to the event.

During the whole event, organisation have to take care, book and pay for the accomodation and meals for the four judges.

JUDGES FEES TERM AND CONDITION

Fees are due to the four judges regarding their judging work.

The judges fees are based on one hundred euros  $(100 \epsilon)$  per day and per judge. The judges fees are due to be paid to the judge directly before the end of the competition. The judges' fees have to be paid in Euros or in local currency.
